- 3. Partner Universities have to send a detailed Erasmus nomination list by e-mail (to <a href="mailto:erasmuskoordinator@iyte.edu.tr">erasmuskoordinator@iyte.edu.tr</a>). It cannot be guaranteed the acceptance of another modality to nominate Erasmus students by partner Universities (such as online nominations etc...).
- 4. The receiving institution will send its decision within 3 weeks.
- 5. A Transcript of Records will be issued by the receiving institution no later than 5 weeks after the assessment period has finished at the receiving HEI.
- 6. Termination of the agreement

In case of earlier unilateral termination, a notice of at least one academic year should be given.
