4. Termination of the agreement

The termination clauses must include the following disclaimer: "Neither the European Commission nor the National Agencies can be held responsible in case of a conflict."]

To pass a course unit, a student must receive a grade of at least 18 points out of 30. 30 e lode is a special mention for outstanding performance. 
