- It is not possible for exchange students to defend their BA/MA/PhD thesis at the host university.
- Incoming international staff members should apply for visits to the departmental coordinators of the respective faculty (<a href="http://www.lu.lv/eng/istudents/exchange/coordinators/">http://www.lu.lv/eng/istudents/exchange/coordinators/</a>) with copy sent to the International Relations department (<a href="ad@lu.lv">ad@lu.lv</a>) of the University of Latvia.

- 2. The receiving institution will send its decision within six weeks.
- 3. A Transcript of Records will be issued by the receiving institution no later than five weeks after the assessment period has finished at the receiving HEI.

In case of the termination, a notice of at least one academic year should be sent to the partner university. Neither the European Commission nor the National Agencies can be held responsible in case of a conflict.
